Description of content: The objective of the notified document PMRL2019-19 is to consult on the listed maximum residue limits (MRLs) for pendimethalin that have been proposed by Health Canada's Pest Management Regulatory Agency (PMRA). <u>MRL (ppm)¹ Raw Agricultural Commodity (RAC) and/or Processed Commodity</u> 0.1 Head and stem <i>Brassica</i> (crop subgroup 5A), tomatoes subgroup (crop subgroup 8-09A) ¹ ppm = parts per million MRLs are proposed for each commodity included in the listed crop groupings in accordance with the <i>Residue Chemistry Crop Groups</i> webpage (https://www.canada.ca/en/health-canada/services/consumer-product-safety/pesticides-pest-management/public/protecting-your-health-environment/pesticides-food/residue-chemistry-crop-groups.html) in the Pesticides and Pest Management section of the Canada.ca website.
