Description of content: The proposed draft Regulation concerns the review of existing MRLs for chromafenozide, fluometuron, pencycuron, sedaxane, tau-fluvalinate and riazoxide in certain food commodities. MRLs for these substances in certain commodities are changed: either increased or lowered. Lower MRLs are set after updating the limits of letermination and/or deleting old uses which are not authorised any more in the European Jnion or for which a human health concern may not be excluded. The residue definition for ome substances has also been updated.
