Description of content:</b> According to the announcement of the Government Gazette dated 24 June 2019, the suspension for importation of live domestic and wild pigs and their carcasses from Viet Nam has expired on 22 September 2019. However, the OIE has reported a continued outbreak of African Swine Fever in many areas such as Ninh Thuan province, Ha Nam province and Dien Bien province in Viet Nam. Therefore, it is necessary for Thailand to prevent the entry of African Swine Fever disease into the country. By the virtue of Animal Epidemics Act B.E. 2558, the importation of live domestic and wild pigs and their carcasses from Viet Nam is temporarily suspended for a period of 90 days after publication in the Thai Royal Gazette (7 October 2019).
