### Established Maximum Residue Limit: Fluazinam

The proposed maximum residue limit (PMRL) document for fluazinam notified in G/SPS/N/CAN/1270 (dated 2 September 2019) was adopted 25 November 2019. The proposed MRL was established via entry into the Maximum Residue Limits Database and is provided directly below:
