The following communication, received on 5 December 2019, is being circulated at the request of the Delegation of <u>Canada</u>.

Established Maximum Residue Limit: Flonicamid

The proposed maximum residue limit (PMRL) document for flonicamid notified in G/SPS/N/CAN/1269 (dated 2 September 2019) was adopted 25 November 2019. The proposed MRL was established via entry into the Maximum Residue Limits Database and is provided directly below:

<u>MRL (ppm)</u>¹ <u>Raw Agricultural Commodity (RAC) and/or Processed Commodity</u>

40 Tea (dried leaves)

¹ ppm = parts per million
