Title of the notified document: The DLD order on temporary suspension of importation of live poultry and poultry carcasses from Viet Nam to prevent the spread of Highly Pathogenic Avian Influenza (subtype H5N6). 6. Description of content: According to the announcement of the Government Gazette dated 15 July 2019, the suspension for importation of live poultry and poultry carcasses from Viet Nam has expired on 13 October 2019. However, the OIE has reported a continued outbreak of Avian Influenza (AI) in Viet Nam. Therefore, it is necessary for Thailand to prevent the entry of AI disease into the country. By the virtue of Animal Epidemics Act B.E. 2558, the importation of live poultry and poultry carcasses from Viet Nam is temporarily suspended for a period of 90 days after date of publication in the Thai Royal Gazette (25 November 2019).
