Description of content:</b> This Draft resolution incorporates the following changes for the active ingredient D36 - DIFENOCONAZOL (difenoconazole) from the Relation of Monographies of Active Ingredients of Pesticides, Household Cleaning Products and Wood Preservers: <ul style="list-style-type: none"><li>- includes the lentil, chickpea, and caupi bean cultures with MRL of 0,08 mg/kg and safety security period of 14 days in the modality of foliar use (application);</li><li>- changes the safety security period of the ground-nut culture from 22 to 14 days in the modality of foliar use (application);</li><li>- changes the MRL of the bean culture from 0,03 to 0,08 mg/kg.</li></ul>

Countries set MRLs according to the good agricultural practice (GAP) applicable to their region. Agricultural chemical use patterns differ between different production regions and countries as pests, diseases and environmental factors vary. This means that Brazilian MRLs for agricultural chemicals in food may differ from Codex standards.</p>
