Description of content:</b> This Draft resolution incorporates the following changes for the active ingredient F53 - FAMOXADONA (famoxadone) from the Relation of Monographies of Active Ingredients of Pesticides, Household Cleaning Products and Wood Preservers, all in the modality of foliar use (application): <ul style="list-style-type: none"><li>- includes the chicory, stevia reubadiana, and mustard cultures with MRL of 2,0 mg/kg and safety security period of 3 days;</li><li>- includes the chinese-cabbage, and brussels sprouts cultures with MRL of 0,05 mg/kg and safety security period of 3 days;</li><li>- includes the chayote, and gherkin cultures with MRL of 0,1 mg/kg and safety security period of 3 days.</li></ul>

Countries set MRLs according to the good agricultural practice (GAP) applicable to their region. Agricultural chemical use patterns differ between different production regions and countries as pests, diseases and environmental factors vary. This means that Brazilian MRLs for agricultural chemicals in food may differ from Codex standards.</p>
