Description of content:</b> This Draft resolution incorporates the following changes for the active ingredient C70 - CLORANTRANILIPROLE (Chlorantraniliprole) from the Relation of Monographies of Active Ingredients of Pesticides, Household Cleaning Products and Wood Preservers: <ul style="list-style-type: none"><li>- includes the red pepper, egg-plant, jilo, okra, and pepper cultures with MRL of 0,3 mg/kg and safety security period of 1 day, in the modality of foliar use (application);</li><li>- includes the ground-nut, beans, pea, chickpea, and lentil cultures with MRL of 0,05 mg/kg and safety security period of 7 days, in the modality of foliar use (application);</li><li>- includes the duboisia culture with MRL and safety security period of "Non-food use", in the modality of foliar use (application);</li><li>- changes the MRL of the ground-nut culture from 0,01 to 0,05 mg/kg in the modality of soil use (application).</li></ul>

Countries set MRLs according to the good agricultural practice (GAP) applicable to their region. Agricultural chemical use patterns differ between different production regions and countries as pests, diseases and environmental factors vary. This means that Brazilian MRLs for agricultural chemicals in food may differ from Codex standards.</p>
