Description of content:</b> This Draft resolution incorporates the following changes for the active ingredient T46 - TETRACONAZOL (tetraconazole), from the Relation of Monographies of Active Ingredients of Pesticides, Household Cleaning Products and Wood Preservers, all in the modality of foliar use (application): <ul style="list-style-type: none"><li>- changes the MRL of the cotton culture from 0,5 to 0,9 mg/kg;</li><li>- changes the MRL of the coffee culture from 0,08 to 0,5 mg/kg;</li><li>- includes the phrase: "acute reference dose (ARfD) = 0,05 mg/kg b.w. (source: EFSA 08)"</li></ul>

Countries set MRLs according to the good agricultural practice (GAP) applicable to their region. Agricultural chemical use patterns differ between different production regions and countries as pests, diseases and environmental factors vary. This means that Brazilian MRLs for agricultural chemicals in food may differ from Codex standards.</p>
