Description of content:</b> This Draft resolution incorporates the following changes for the active ingredient F49 - FLUDIOXONIL (fludioxonil) from the Relation of Monographies of Active Ingredients of Pesticides, Household Cleaning Products and Wood Preservers, all in the modality of foliar use (application): <ul style="list-style-type: none"><li>- includes the pineapple, papaya, and mango cultures with MRL of 6,0 mg/kg and safety security period "Not determined due to the modality of use (application)";</li><li>- includes the banana culture with MRL 30,0 mg/kg and safety security "Not determined due to the modality of use (application)";</li><li>- changes the MRL of the citrus culture from 0,3 to 8,0 mg/kg.</li></ul>

Countries set MRLs according to the good agricultural practice (GAP) applicable to their region. Agricultural chemical use patterns differ between different production regions and countries as pests, diseases and environmental factors vary. This means that Brazilian MRLs for agricultural chemicals in food may differ from Codex standards.</p>
