Adopt statistical concepts (three-class attributes plans) for microbiological specifications for twenty food types including noodles, sauces, etc.;3. Establish and revise maximum residue limits for pesticides:<ul style="list-style-type: none">– Establish maximum residue limits for newly registered pesticides (oxathiapiprolin, indaziflam, isoxaflutole);– Revise maximum residue limits for pesticides in 32 agricultural products;– Establish maximum residue limits for deltamethrin and fenpyrazamine in ginseng;4. Establish and revise maximum residue limits for veterinary drugs in foods:<ul style="list-style-type: none">– Establish maximum residue limits for twenty six veterinary drugs in porcine muscle;5. Revise general testing methods.
