**6. Description of content:** Health Canada's Food Directorate completed a detailed safety assessment of a food additive submission seeking approval for the use of saccharin, calcium saccharin, potassium saccharin and sodium saccharin as sweeteners in preoperative beverages.

Saccharin and its salts are already permitted for use in Canada as sweeteners in various food categories.

As no safety concerns were raised through Health Canada's assessment the Department has enabled the food additive use of saccharin, calcium saccharin, potassium saccharin and sodium saccharin as sweeteners in preoperative beverages described in the information document below by updating the *List of Permitted Sweeteners* (http://www.hc-sc.gc.ca/fn-an/securit/addit/list/9-sweetener-edulcorant-eng.php),

effective 21 January 2016. The purpose of this communication is to publically announce the Department's decision in this regard and to provide the appropriate contact information for any inquiries or for those wishing to submit any new scientific information relevant to the safety of this food additive.

Health Canada's Food Directorate is committed to reviewing any new scientific information on the safety in use of any food additive, including saccharin and its calcium, potassium and sodium salts in preoperative beverages.
