The following communication, received on 22 February 2016, is being circulated at the request of the Delegation of the <u>Separate Customs Territory of Taiwan, Penghu, Kinmen and Matsu</u>.

Draft of the use restriction of edible hydrogenated oils

The Separate Customs Territory of Taiwan, Penghu, Kinmen and Matsu proposed amendments to the Draft of Sanitation for Edible Hydrogenated Oils dated 7 September 2015 (G/SPS/N/TPKM/367). The content of the Draft of the use restriction of edible hydrogenated oils is modified in this Addendum to Regular Notification.

Products Covered: Partially hydrogenated oils for use in human food. The use of partially hydrogenated oils in food is prohibited. Implementation date: 1 July 2018. Draft of the use restriction of edible hydrogenated oils (MOHW Food No. 1051300105, 22 February 2016) is available in Chinese from the Ministry of Health and Weldare.
