The CODEX STAN 243 includes Fermented Milk, Concentrated Fermented Milk and Flavoured Fermented Milks. And Fermented milk includes Yoghurt, Alternate Culture Yoghurt, Acidophilus Milk, Kefir, Kumys and other categories.

Fermented milk in GB19302 includes Yoghurt and Flavoured Fermented Milks.

(2) Different provisions on the use ratio of other raw materials for flavoured fermented milk.

CODEX STAN 243 stipulates that the use ratio of non-dairy raw materials shall be 50%, while GB19302 requires milk raw materials shall be no less than 80%.
