# NOTIFICATION

## Addendum

The following communication, received on 14 September 2020, is being circulated at the request of the Delegation of <u>Canada</u>.

## Established Maximum Residue Limit: Fenpropathrin

The proposed maximum residue limit (PMRL) document for fenpropathrin notified in G/SPS/N/CAN/1310 (dated 16 June 2020) was adopted 6 September 2020. The proposed MRL was established via entry into the Maximum Residue Limits Database and is provided directly below:

MRL (ppm)1Raw Agricultural Commodity (RAC) and/or Processed Commodity0.15Tree nuts (crop group 14-11)2

<sup>1</sup>ppm = parts per million

<sup>2</sup>This MRL replaces the currently established MRL of 0.10 ppm for crop group 14.

An MRL is established for each commodity included in the listed crop groupings in accordance with the *Residue Chemistry Crop Groups* webpage (<u>https://www.canada.ca/en/health-canada/services/consumer-product-safety/pesticides-pest-management/public/protecting-your-health-environment/pesticides-food/residue-chemistry-crop-groups.html</u>) in the Pesticides and Pest Management section of the Canada.ca website.

The database allows users to search for pesticides or for food commodities.
