- **6. Description of content:** The objective of the notified document PMRL2020-29 is to consult on the listed maximum residue limits (MRLs) for mandestrobin that have been proposed by Health Canada's Pest Management Regulatory Agency (PMRA).

Raw Agricultural Commodity (RAC) and/or Processed Commodity
Legume vegetables (succulent or dried) (crop group 6), field corn,
popcorn grain, sweet corn kernels plus cob with husks removed
