The Separate Customs Territory of Taiwan, Penghu, Kinmen and Matsu notified the draft amendment of Article 8-1 of the "Quarantine Requirements for the Importation of Animals and Animal Products" on 1 July 2020 (G/SPS/N/TPKM/516/Rev.1). The amendment was promulgated on 29 September 2020 and will become effective on 1 January 2021.
