Description of content:</b> The measure changes the conditions of use of the novel food 'trans-resveratrol' by removing the specific delivery formats, capsule or tablet form, as the only allowed forms of the food supplements containing the novel food 'trans-resveratrol' as listed in the Union list. Thus, the novel food will be authorised for use in any form of food supplements at the previously authorised maximum level.
