#### Addendum

The following communication, received on 9 February 2021, is being circulated at the request of the Delegation of Canada.

### Established Maximum Residue Limit: Tetraconazole

The proposed maximum residue limit (PMRL) document for tetraconazole notified in G/SPS/N/CAN/1351 (dated 18 November 2020) was adopted 4 February 2021. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:
