The following communication, received on 10 February 2021, is being circulated at the request of the Delegation of <u>Canada</u>.

Established Maximum Residue Limit: Carfentrazone-ethyl

The proposed maximum residue limit (PMRL) document for carfentrazone-ethyl notified in G/SPS/N/CAN/1355 (dated 20 November 2020) was adopted 8 February 2021. The proposed MRL was established via entry into the Maximum Residue Limits Database and is provided directly below:

MRL (ppm)¹ Raw Agricultural Commodity (RAC) and/or Processed Commodity

0.10 Tree nuts (crop group 14-11)

An MRL is established for each commodity included in the listed crop groupings in accordance with the *Residue Chemistry Crop Groups* webpage (https://www.canada.ca/en/health-canada/services/consumer-product-safety/pesticides-pest-management/public/protecting-your-health-environment/pesticides-food/residue-chemistry-crop-groups.html) in the Pesticides and Pest Management section of the Canada.ca website.
