Description of content:</b> This Draft resolution incorporates the following changes for the active ingredient F23.1 - FLUASIFOPE-P-BUTÍLICO (fluazifop-P) from the Relation of Monographies of Active Ingredients of Pesticides, Household Cleaning Products and Wood Preservers, all in the modality of foliar use (application): <ul style="list-style-type: none"><li>- changes the MRL of the bean culture from 1.0 to 7.0 mg/kg;</li><li>- includes the phrase at item "h": "Acute Reference Dose (ArfD): 0.4 mg/kg b.w. (source: JMPR*, 2005);</li><li>- includes the phrase: "*Joint FAO/WHO Meeting on Pesticide Residues";</li><li>- includes the phrase at item "i": "for the purpose of residue definition for conformity to MRL and dietary risk assessment, it will be considered the sum of all the constituent isomers of fluazifop, its esters including conjugates, expressed as fluazifop".</li></ul>

Countries usually set MRLs according to the Good Agricultural Practice (GAP) applicable to their region. Agricultural chemical use patterns differ between different production regions and countries as pests, diseases and environmental factors vary. This means that Brazilian MRLs for agricultural chemicals in food may differ from Codex standards. However, when a product differs from Brazilian MRLs, but is in conformity to Codex standards, it may be imported, provided that the risk assessment does not indicate an unacceptable risk to Brazilian consumers.</p>	<p><b>Is there a relevant international standard?
