Description of content:** This Draft resolution incorporates the following changes for the active ingredient C-60 ZETA-CIPERMETRINA (zeta-cypermethrin) from the Relation of Monographies of Active Ingredients of Pesticides, Household Cleaning Products and Wood Preservers, all in the modality of foliar use (application):
 - includes the sweet potato, beetroot, carrot, ginger, yam, arracacha, turnip, and radish cultures with MRL of 0.05 mg/kg and safety security period of 7 days;
 - includes the phrase at item "o": "Acute Reference Dose (ARfD): 0.04 mg/kg b.w. (source: JMPR*, 2006);
 - includes the phrase: "*Joint FAO/WHO Meeting on Pesticide Residues".

If no, describe, whenever possible, how and why it deviates from the international standard: Brazilian MRLs are established based on scientific methodology consistent with international best practices. Countries usually set MRLs according to the Good Agricultural Practice (GAP) applicable to their region. Agricultural chemical use patterns differ between different production regions and countries as pests, diseases and environmental factors vary. This means that Brazilian MRLs for agricultural chemicals in food may differ from Codex standards. However, when a product differs from Brazilian MRLs, but is in conformity to Codex standards, it may be imported, provided that the risk assessment does not indicate an unacceptable risk to Brazilian consumers.
