Description of content: Amendment of pesticide MRLs for Bicyclopyrone, Cartap, Chlorfluazuron, Chlorpyrifos, Clothianidin, Cyantraniliprole, Cyazofamid, Cyenopyrafen, Cyflufenamid, Ethiprole, Etofenprox, Flonicamid, Florpyrauxifen-benzyl, Fluazinam, Flupyradifurone, Flutriafol, Fosetyl-aluminium, Fosthiazate, Hexaconazole, Imidacloprid, Isofetamid, Isotianil, Kresoxim-methyl, Lufenuron, Metaldehyde, Methoxyfenozide, Milbemectin, Oxolinic acid, Pencycuron, Penthiopyrad, Pydiflumetofen, Pyflubumide, Pyribencarb, Quinoxyfen, Sedaxane, Sethoxydim, Spinetoram, Spinosad, Sulfoxaflor, Tebuconazole, Tetraconazole, Tolclofos-methyl and Trifloxystrobin in cereal grains, sugarcane, coffee beans, dried beans, tree nuts, fruits and vegetables. Addendum of Bacillus amyloliquefaciens Tcba05, Bacillus velezensis BF and Prohydrojasmon as MRLs omitted pesticides. Addendum of Gac fruit classified as melon vegetables.
