## NOTIFICATION

### *Addendum*

The following communication, received on 24 June 2021, is being circulated at the request of the Delegation of Canada.

#### Established Maximum Residue Limit: Rimsulfuron

The proposed maximum residue limit (PMRL) document for rimsulfuron notified in G/SPS/N/CAN/1379 (dated 31 March 2021) was adopted 21 June 2021. The proposed MRL was established via entry into the Maximum Residue Limits Database and is provided directly below:

#### MRL (ppm)<sup>1</sup> Raw Agricultural Commodity (RAC) and/or Processed Commodity

0.01 Small fruits vine climbing, except fuzzy kiwifruit (crop subgroup 13-07F, except gooseberries)<sup>2</sup>

<sup>1</sup> ppm = parts per million

<sup>2</sup> Gooseberries are excluded from this MRL action as a 0.01 ppm MRL is already established for this commodity.

An MRL is established for each commodity included in the listed crop groupings in accordance with the *Residue Chemistry Crop Groups* webpage (<https://www.canada.ca/en/health-canada/services/consumer-product-safety/pesticides-pest-management/public/protecting-your-health-environment/pesticides-food/residue-chemistry-crop-groups.html>) in the Pesticides and Pest Management section of the Canada.ca website.
