<b>6. Description of content:</b> Regulation (EC) No 1831/2003 provides for the authorisation of additives for use in animal nutrition and for the grounds and procedures for granting such an authorisation. In accordance with Article 7 of Regulation (EC) No 1831/2003, applications were submitted for the authorisation of L-lysine base, L-lysine monohydrochloride and L-lysine sulphate. The applications were accompanied by the particulars and documents required under Article 7(3) of that Regulation. The applications concern the authorisation of L-lysine base and L-lysine monohydrochloride produced by <i>Corynebacterium glutamicum</i> KCCM 80183, L-lysine monohydrochloride and L-lysine sulphate produced by <i>Corynebacterium glutamicum</i> CCTCC M 2015595 and L-lysine sulphate produced by <i>Corynebacterium glutamicum</i> KCCM 80227 as feed additives for all animal species, to be classified in the additive category 'nutritional additives', functional group 'amino acids, their salts and analogues'.
