<b>6. Description of content:</b> The proposed draft Regulation concerns the review of existing MRLs for methoxyfenozide, propoxur, spinosad and thiram in certain food commodities. MRLs for these substances in certain commodities are changed. Lower MRLs are set after updating the limits of determination and/or deleting old uses which are not authorised any more in the European Union or for which a human health concern may not be excluded.
