6. Description of content: The text removes the authorization to use titanium dioxide (E 171) in foods based on the recent scientific opinion of the European Food Safety Authority (EFSA) concluding that titanium dioxide can no longer be considered as safe when used as a food additive.

In order to allow for a smooth transition, the text lays down that foods that contain titanium dioxide (E 171) used in accordance with the rules applicable before the date of entry into force of the ordinance may be placed on the market until six months after that date. Those foods may then continue to be marketed until their date of minimum durability or "use by" date.

- 7. Objective and rationale: [X] food safety, [] animal health, [] plant protection, [] protect humans from animal/plant pest or disease, [] protect territory from other damage from pests. On 6 May 2021, EFSA published an updated safety assessment for E 171. According to this, E 171 is no longer considered safe for use as a food additive. The EFSA safety assessment found that titanium dioxide is absorbed from the gastrointestinal tract to a very low extent, but takes a long time to be excreted from the body. In addition, titanium dioxide has the potential to accumulate in tissues. After evaluation of the available data, the suspicion of a mutagenic effect of titanium dioxide could not be invalidated. Based on this safety assessment, Switzerland decided that this additive should no longer be used in food.

	If no, describe, whenever possible, how and why it deviates from the international standard: The measure to no longer allow the use of titanium dioxide in foods is the consistant application of the knowledge gained from the recent EFSA scientific opinion on titanium dioxide (E 171). It concluded that titanium dioxide can no longer be considered as safe when used as a food additive.
