Addendum

The following communication, received on 11 February 2022, is being circulated at the request of the Delegation of Canada.

Established Maximum Residue Limit: Dimethomorph

The proposed maximum residue limit (PMRL) document for dimethomorph notified in G/SPS/N/CAN/1399 (dated 1 July 2021) was adopted 1 February 2022. The proposed MRL was established via entry into the Maximum Residue Limits Database and is provided directly below:

MRL (ppm)¹ Raw Agricultural Commodity (RAC) and/or Processed Commodity

1.5 Caneberries (crop subgroup 13-07A)

¹ppm = parts per million

An MRL is established for each commodity included in the listed crop groupings in accordance with the *Residue Chemistry Crop Groups* webpage (<https://www.canada.ca/en/health-canada/services/consumer-product-safety/pesticides-pest-management/public/protecting-your-health-environment/pesticides-food/residue-chemistry-crop-groups.html>) in the Pesticides and Pest Management section of the Canada.ca website.

The database allows users to search for pesticides or for food commodities.
