The following communication, received on 11 February 2022, is being circulated at the request of the Delegation of <u>Canada</u>.

Established Maximum Residue Limit: Picoxystrobin

The proposed maximum residue limit (PMRL) document for picoxystrobin notified in G/SPS/N/CAN/1398 (dated 1 July 2021) was adopted 1 February 2022. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

MRL (ppm) ¹	Raw Agricultural Commodity (RAC) and/or Processed Commodity
2.0	Edible pedded legume vegetables (even subgroup EA)

2.0 Edible-podded legume vegetables (crop subgroup 6A)0.9 Succulent shelled pea and bean (crop subgroup 6B)

An MRL is established for each commodity included in the listed crop groupings in accordance with the *Residue Chemistry Crop Groups* webpage (https://www.canada.ca/en/health-canada/services/consumer-product-safety/pesticides-pest-management/public/protecting-your-health-environment/pesticides-food/residue-chemistry-crop-groups.html) in the Pesticides and Pest Management section of the Canada.ca website.
