#### Addendum

The following communication, received on 21 February 2022, is being circulated at the request of the Delegation of <u>Canada</u>.

## Established Maximum Residue Limit: Mandipropamid

The proposed maximum residue limit (PMRL) document for mandipropamid notified in G/SPS/N/CAN/1403 (dated 16 July 2021) was adopted 15 February 2022. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

MRL (ppm)<sup>1</sup> Raw Agricultural Commodity (RAC) and/or Processed Commodity

15 Citrus oil

0.5 Citrus fruits (crop group 10) (revised)
