The proposed MRLs for muscle of chicken (0.1 ppm) is based on the results of separate indirect spraying tests in poultry houses. The proposed MRLs for muscle of other poultry (0.05 ppm) is based on the results of farm animal feeding studies. These trials were conducted under the normal use methods stipulated by domestic law.</p>
