Addendum

The following communication, received on 17 March 2022, is being circulated at the request of the Delegation of <u>Canada</u>.

Established Maximum Residue Limit: Bromoxynil

The proposed maximum residue limit (PMRL) document for bromoxynil notified in G/SPS/N/CAN/1409 (dated 28 July 2021) was adopted 15 March 2022. The proposed MRL was established via entry into the Maximum Residue Limits Database and is provided directly below:

<u>MRL (ppm)</u>¹ <u>Raw Agricultural Commodity (RAC) and/or Processed Commodity</u>

- 0.05 Annual canarygrass grain
- ¹ ppm = parts per million

In addition, this addendum clarifies the maximum residue limit proposed for annual canarygrass seeds cited in notification G/SPS/N/CAN/1409. The notification proposed a 0.05 ppm maximum residue limit for annual canarygrass seeds. Health Canada's MRL Database has recently been updated (<u>https://pr-rp.hc-sc.gc.ca/mrl-lrm/index-eng.php</u>), and the English crop descriptor for annual canarygrass seeds has been revised to annual canarygrass grain. There is no change to the French crop descriptor.

MRLs established in Canada may be found using Health Canada's *Maximum Residue Limit Database* (<u>http://pr-rp.hc-sc.gc.ca/mrl-Irm/index-eng.php</u>) on the *Maximum Residue Limits for Pesticides* webpage (<u>https://www.canada.ca/en/health-canada/services/consumer-product-safety/pesticides-pest-management/public/protecting-your-health-environment/pesticides-food/maximum-residue-limits-pesticides.html</u>). The database allows users to search for pesticides or for food commodities.
