Addendum

The following communication, received on 17 March 2022, is being circulated at the request of the Delegation of <u>Canada</u>.

Established Maximum Residue Limit: Boscalid

The proposed maximum residue limit (PMRL) document for boscalid notified in G/SPS/N/CAN/1406 (dated 28 July 2021) was adopted 15 March 2022. The proposed MRL was established via entry into the Maximum Residue Limits Database and is provided directly below:

MRL (ppm)¹ Raw Agricultural Commodity (RAC) and/or Processed Commodity

- 30 Caraway fruits
- ¹ ppm = parts per million

In addition, this addendum clarifies the maximum residue limit proposed for caraway seeds cited in notification G/SPS/N/CAN/1406. The notification proposed a 30 ppm maximum residue limit for caraway seeds. Health Canada's MRL Database, however, has recently been updated (<u>https://pr-rp.hc-sc.gc.ca/mrl-lrm/index-eng.php</u>), and the crop descriptor for caraway seeds has been revised to caraway fruits.

MRLs established in Canada may be found using Health Canada's *Maximum Residue Limit Database* (<u>http://pr-rp.hc-sc.gc.ca/mrl-lrm/index-eng.php</u>) on the *Maximum Residue Limits for Pesticides* webpage (<u>https://www.canada.ca/en/health-canada/services/consumer-product-safety/pesticides-pest-management/public/protecting-your-health-environment/pesticides-food/maximum-residue-limits-pesticides.html</u>). The database allows users to search for pesticides or for food commodities.
