Description of content: The proposed Poultry Health Regulations set out disease prevention, control and eradication measures for OIE listed poultry diseases, particularly for Avian influenza and Newcastle Disease, as well as for diseases and conditions of national importance. They also provide an enabling structure to implement disease surveillance for early detection and rapid response with the ultimate goal of preventing, controlling and eradicating poultry disease in Belize.
