Description of content:</b> The objective of the notified document PMRL2022-06 is to consult on the listed maximum residue limits (MRLs) for flutriafol that have been proposed by Health Canada's Pest Management Regulatory Agency (PMRA).  <u>MRL (ppm)<sup>1</sup> Raw Agricultural Commodity (RAC) and/or Processed Commodity</u> 20 Hops (dried cones) 0.6 Almond nuts  <sup>1</sup> ppm = parts per million
