This delegated Regulation provides additional requirements based on Article 19(2) of Regulation (EU) 2017/625 to those laid down in implementing Regulation SANTE 11186-2018. This delegated act sets out specific requirements regarding the content of the national control plans for contaminants, such as sampling frequency, range of samples and stage of production, processing and distribution where the samples are to be taken and criteria to be taken into account for the design of the control plans. 7.
