Description of content:</b> According to the announcement of the Government Gazette dated 17 January 2022, the suspension for importation of live poultry and poultry carcasses from Viet Nam has expired on 16 April 2022. However, the OIE has reported a continued outbreak of Highly Pathogenic Avian Influenza (HPAI) in the area of Viet Nam. Therefore, it is necessary for Thailand to prevent the entry of Highly Pathogenic Avian Influenza (HPAI) disease into the country. By the virtue of Animal Epidemics Act B.E. 2558 (2015), the importation of live poultry and poultry carcasses from Viet Nam is temporarily suspended for a period of 90 days notified since 17 April 2022 onward in the Thai Royal Gazette.
