Description of content: The objective of the notified document PMRL2022-07 is to consult on the listed maximum residue limits (MRLs) for topramezone that have been proposed by Health Canada's Pest Management Regulatory Agency (PMRA). <u>MRL (ppm)¹ Raw Agricultural Commodity (RAC) and/or Processed Commodity</u> 0.05 Fat and meat byproducts of poultry ² 0.01 Rapeseeds ³ (crop subgroup 20A) (revised); eggs and meat of poultry ² ¹ ppm = parts per million. ² From poultry consumption of feed treated with topramezone. ³ Canola is a variety of rapeseed. An MRL is proposed for each commodity included in the listed crop groupings in accordance with the <i>Residue Chemistry Crop Groups</i> webpage (https://www.canada.ca/en/health-canada/services/consumer-product-safety/pesticides-pest-management/public/protecting-your-health-environment/pesticides-food/residue-chemistry-crop-groups.html) in the Pesticides and Pest Management section of the Canada.ca website.
