6.	<b>Description of content:</b> The Implementing Regulation authorizes the removal of the particle size requirement in the specifications of <i>trans</i> -resveratrol produced from microbial sources to align its specifications with the synthetic <i>trans</i> -resveratrol, which has a comparable particle size profile but no particle size requirement in its specifications.
