The following communication, received on 1 June 2022, is being circulated at the request of the Delegation of the <u>United States of America</u>.

<u>Natural Resources Defense Council, et al.; Denial of Food Additive Petition; Denial Without Prejudice of Food Additive Petition</u>

The Food and Drug Administration (FDA or we) is denying a food additive petition (FAP 6B4815) submitted by Natural Resources Defense Council, et al., requesting that we amend or revoke specified regulations to no longer provide for the food contact use of 28 ortho-phthalates. (We use the terms "phthalates" and "orthophthalates" interchangeably in this notification to refer to the subset of phthalates substituted in the "ortho" position).
