Description of content: This regulation establishes an exemption from the requirement of a tolerance for residues of the <i>Bacillus amy loliq uefaciens</i> strain PTA-4838 on all food commodities when applied or used as a fungicide, nematocide, or plant growth regulator. This regulation eliminates the need to establish a maximum permissible level for residues of <i>Bacillus amy loliq uefaciens</i> strain PTA-4838.
