Compared with GB 1886.96-2016, the main changes of this standard are as follows: <ul style="list-style-type: none">- The acid value as coating agent is modified;- The solubility experiment as coating agent and gum base agent was modified;- Infrared spectrum as coating agent is added;- The saponification value standard as film coating agent is added.
