- 6. **Description of content:** The proposed Draft amendment to the Regulations makes provision for the maximum limits for pesticide residues in foodstuffs under the control of the Department of Health, in terms of the Foodstuffs, Cosmetic and Disinfectants Act, 1972 (Act 54 of 1972)

In addition, exposure assessments of pesticides are conducted using South African consumption data. The original regulation, however, indicates that where food is imported into South Africa, and if MRLs are more restrictive that Codex MRLs, the Codex MRL will be accepted provided that the exposure to the population is not a risk to human safety. 9.
