Addendum

The following communication, received on 25 January 2023, is being circulated at the request of the Delegation of <u>Canada</u>.

Established Maximum Residue Limit: Dicamba

The proposed maximum residue limit (PMRL) document for dicamba notified in G/SPS/N/CAN/1461 (dated 20 October 2022) was adopted 16 January 2023. The proposed MRL was established via entry into the Maximum Residue Limits Database and is provided directly below:

MRL (ppm)¹ Raw Agricultural Commodity (RAC) and/or Processed Commodity

0.02 Annual canarygrass grain

¹ ppm = parts per million
