6.	Description of content: The objective of the notified document PMRL2023-07 is to consult on the listed maximum residue limits (MRLs) for fluazinam that have been proposed by Health Canada's Pest Management Regulatory Agency (PMRA).

	 3.0 Grapes 0.07 Cucurbit vegetables (crop group 9)²
	 ¹ ppm = parts per million ² While there are MRLs currently established for commodities within crop subgroup 9A (melon) at 0.07 ppm, the MRLs will be expanded to cover all commodities within crop group 9 (cucurbit vegetables). Hence a crop group MRL for cucurbit vegetables is being proposed, while the current MRLs for individual commodities within crop subgroup 9A will be expired.
