Description of content: This draft resolution is regarded the proposal for the inclusion of the monographs of the active ingredients A26 – AZOXYSTROBIN, B29 – BUPROFEZINE, B37 – POTASSIUM BICARBONATE, C63 – LAMBDA-CYTHOTHRINE, C70 - CHLORANTHRANILIPROLE, C74 – CYANTRANILIPROLE, D25 – DIUROM, D36 - DIPHENOCONAZOLE, F49 – FLUDIOXONIL, F50 – PHOSTIAZATE, and F68 - FLUXAPYROXADE on the Monograph List of Active Ingredients for Pesticides, Household Cleaning Products and Wood Preservers, published by Normative Instruction number 103 - 19 October 2021 on the Brazilian Official Gazette (DOU - Diário Oficial da União).

Countries usually set MRLs according to the Good Agricultural Practice (GAP) applicable to their region. Agricultural chemical use patterns differ between different production regions and countries as pests, diseases and environmental factors vary. This means that Brazilian MRLs for agricultural chemicals in food may differ from Codex standards. However, when a product differs from Brazilian MRLs, but is in conformity to Codex standards, it may be imported, provided that the risk assessment does not indicate an unacceptable risk to Brazilian consumers.</p>
