Simplify and reclassify food types;5. Clarify the requirements for raw materials;6. Add metabolites to residue definition for veterinary drugs;7. Rationalize storage and distribution standards;8. Improve microorganisms and introduce statistical concepts;9. Modify terminologies and wordings such as refining the definitions of food type;10. Revise the methods of sampling and sample handling;11. Establish and revise the general test methods; and12. Establish and revise the maximum residue limits for pesticides in agricultural products.
