Description of content: The New Zealand Ministry for Primary Industries is publicly consulting on the following proposed amendments to the import health standard 155.02.06: <i>Importation of Nursery Stock</i> : <ul style="list-style-type: none">• Amending the current onshore chemical treatment options for <i>D. deremensis</i> whole plants and non-dormant cuttings;• Adopting the onshore chemical treatment options to all whole plants and non-dormant cuttings <i>Dracaena</i> species eligible for importation into New Zealand;• Adding a spraying option for the application of the onshore chemical treatment for whole plants and non-dormant cuttings of <i>Dracaena</i> species;• Clarifying that onshore treatment is mandatory for all whole plants and non-dormant cuttings <i>Dracaena</i> species. Transferring the <i>Dracaena</i> onshore treatment requirements to the New Zealand Approved Biosecurity Treatments Standard (ABTRT).
