Addendum

The following communication, received on 7 March 2023, is being circulated at the request of the Delegation of <u>Canada</u>.

Established Maximum Residue Limits: Pyrifluquinazon

The proposed maximum residue limit (PMRL) document for pyrifluquinazon notified in G/SPS/N/CAN/1467 (dated 5 December 2022) was adopted 28 February 2023. The proposed MRLs were established via entry into the Maximum Residue Limits Database and are provided directly below:

MRL (ppm)¹ Raw Agricultural Commodity (RAC) and/or Processed Commodity

30	Citrus oil
20	Tea (dried leaves)
5.0	Leafy vegetables (crop group 4-13)
1.5	Leaf petioles vegetables (crop subgroup 22B)
0.7	Citrus fruits (crop group 10) (revised)
0.6	Brassica head and stem vegetables (crop group 5-13)
0.3	Fruiting vegetables (crop group 8-09); cherries (crop subgroup 12-09A); small fruits vine climbing, except fuzzy kiwifruit (crop subgroup13-07F); undelinted cotton seeds
0.07	Cucurbit vegetables (crop group 9); pome fruits (crop group 11-09)
0.04	Peaches (crop subgroup 12-09B)
0.02	Tuberous and corm vegetables (crop subgroup 1C); plums (crop subgroup 12-09C); tree nuts (crop group 14-11)
